#### **Description of necessary first aid measures**

: Extremely flammable aerosol. Runoff to sewer may create fire or explosion hazard. #### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

In the case of aerosols being ruptured, care should be taken due to the rapid escape of the pressurized contents and propellant. ### Methods and materials for containment and cleaning up

Small spill

## Appropriate engineering controls

: Use only with adequate ventilation. If user operations generate dust, fumes, gas, vapor or mist, use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits.
