Specific hazards arising from the chemical

: Extremely flammable aerosol. Runoff to sewer may create fire or explosion hazard. ### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

### Methods and materials for containment and cleaning up

Small spill

# Appropriate engineering controls
